While cementing the production casing, operator did not witness a wiper plug bump. After a coiled tubing clean-out was performed, the production casing was pressure tested. Operator was able to establish injection rate indicating a wet shoe in the production string.

Current casing shoe is at 14,299' M.D. 330' toe-hardline is at 14,193' M.D. Pre-frac plat attached.

Operator plans discussed with Mr. Gilbert Cordero are to run a composite-bridge plug rated to 10,000 psi to a depth of 14,125' M.D. and then perform casing integrity test to 7,500 psi. After a successful casing test, we will continue with planned perforation and stimulation procedures of original design. The bridge plug will remain in the casing for the life of the well providing isolation from shoe to remainder of wellbore.

Operator plans to move in and rig up equipment for this operation starting 4/26/2017 and plans to have the new successful casing integrity test completed by 4/28/2017. Operator will send successful results to Mr. Gilbert Cordero.


