5/30/17 – MIRU. Loaded tubing with 1-1/2 bbls. Tested to 200 psi, good. Unseat pump. Pumped 20 bbls hot water down tubing. Bled down. Pumped 30 bbls down casing, well on vacuum. ND wellhead and NU BOP. POOH with tubing. RIH with GR/JB to 2625'. Set a CIBP at 2625'. Tagged CIBP. Attempted to load well with 60 bbls, did not load.

5/31/17 – RIH with gyro survey tool and surveyed well from surface to 2600'. Set a 4-1/2" CIBP at 2573'. Pumped 50 bbls, did not load up. Spotted 104 sx Class "C" cement. Displaced with 3 bbls. WOC. Tagged TOC at 2368'. Broke circulation with 33 bbls. Spotted 89 sx Class "C" cement at 2368'. Approximate TOC at 1070'.

6/1/17 – Tagged TOC at 1075'. Perforated at 1018'. Pumped down 4-1/2" casing. Pressured up to 500 psi, good. Bled down. Perforated at 360'. Pumped down 4-1/2" casing to 500 psi in 2 min, drop to 0 psi. Could not establish rate. As per Bob Byrd with Artesia-NMOCD, fill up 4-1/2" casing with cement. ND BOP. Spotted 75 sx Class "C" cement up 4-1/2" casing from 1070' up to surface. Topped off 4-1/2" casing with Class "C" cement.

6/7/17 – Dug up cellar and cut off wellhead. Install dry hole marker. Cover cellar and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**
