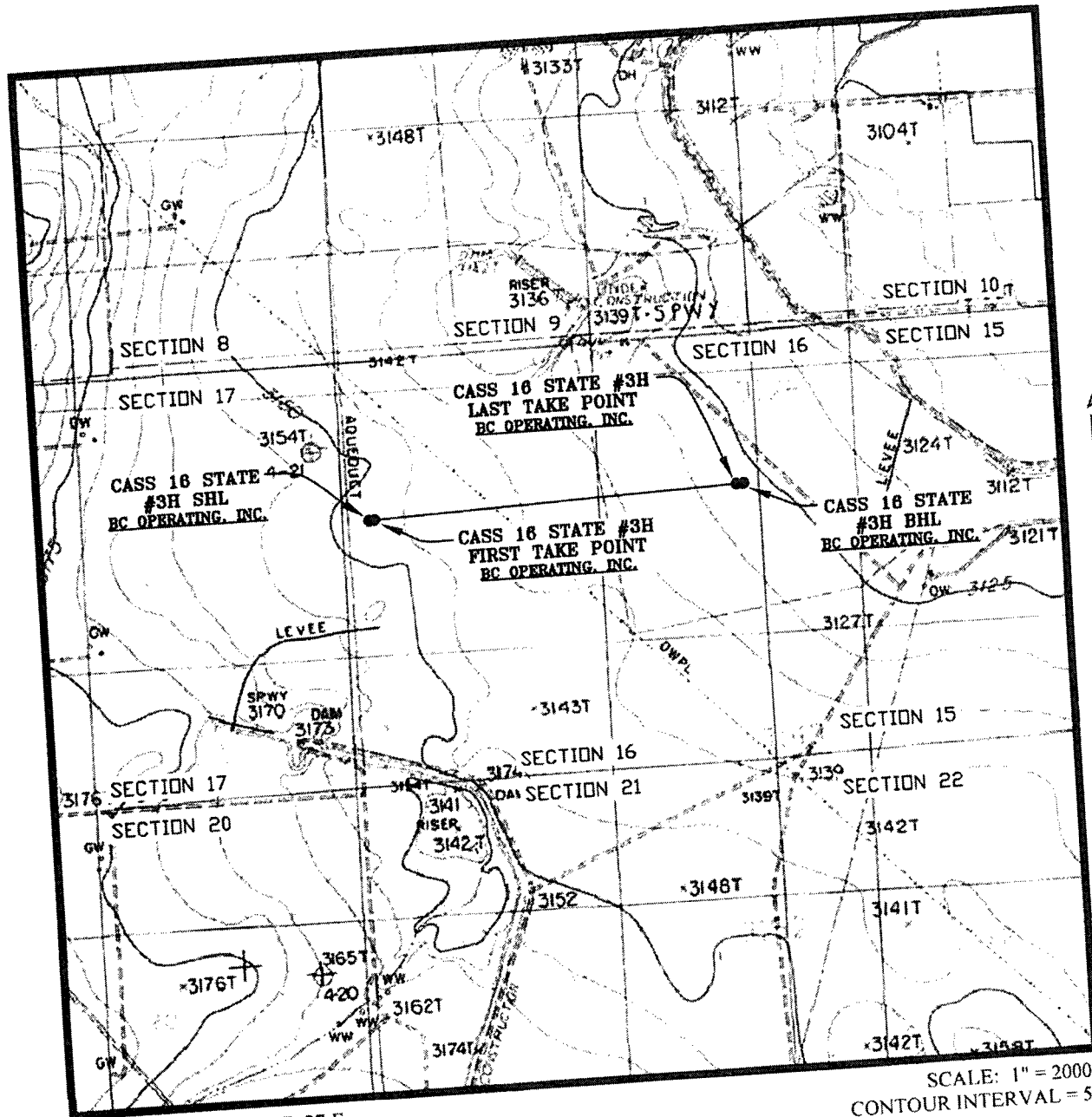

LOCATION VERIFICATION MAP

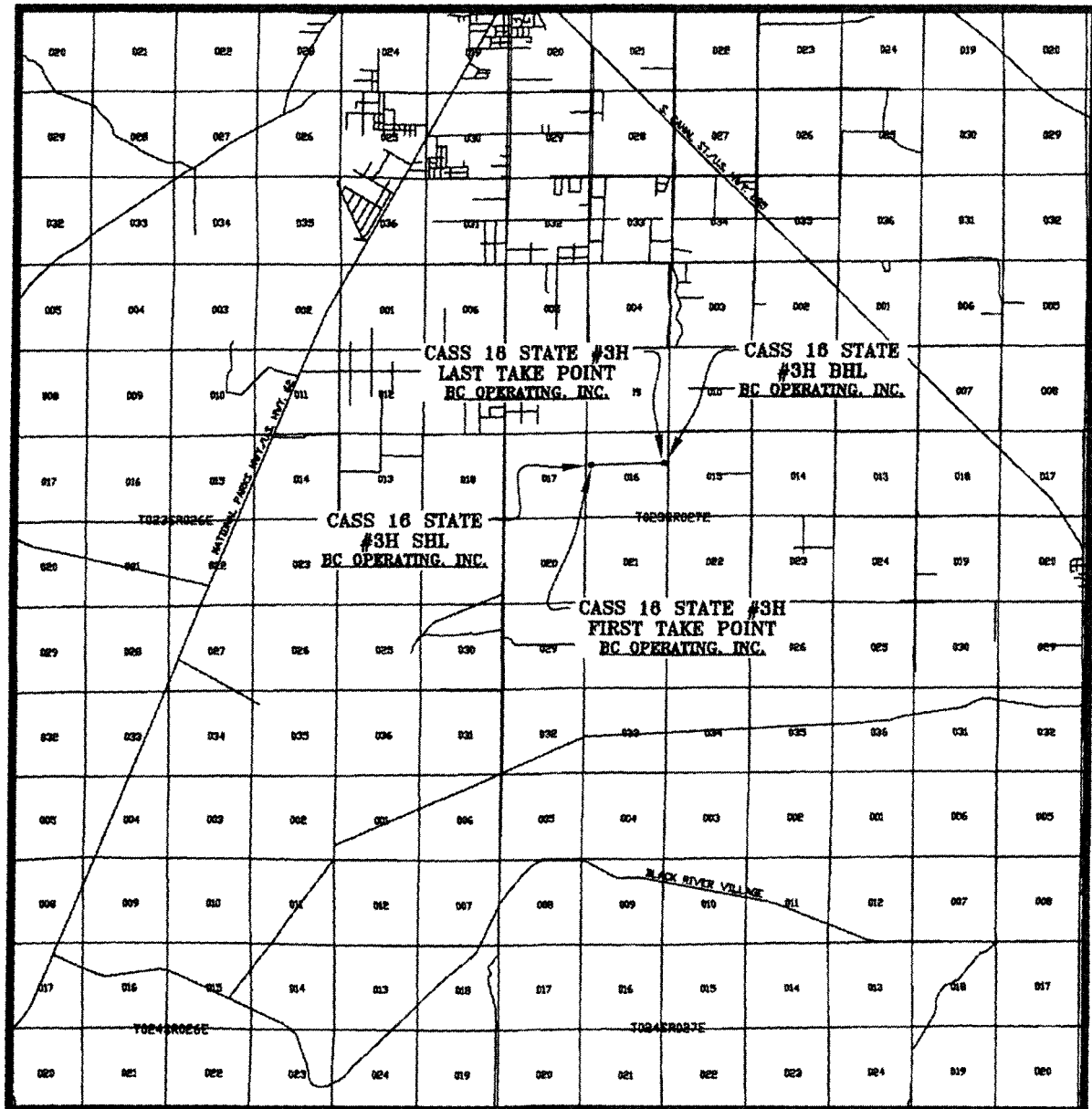

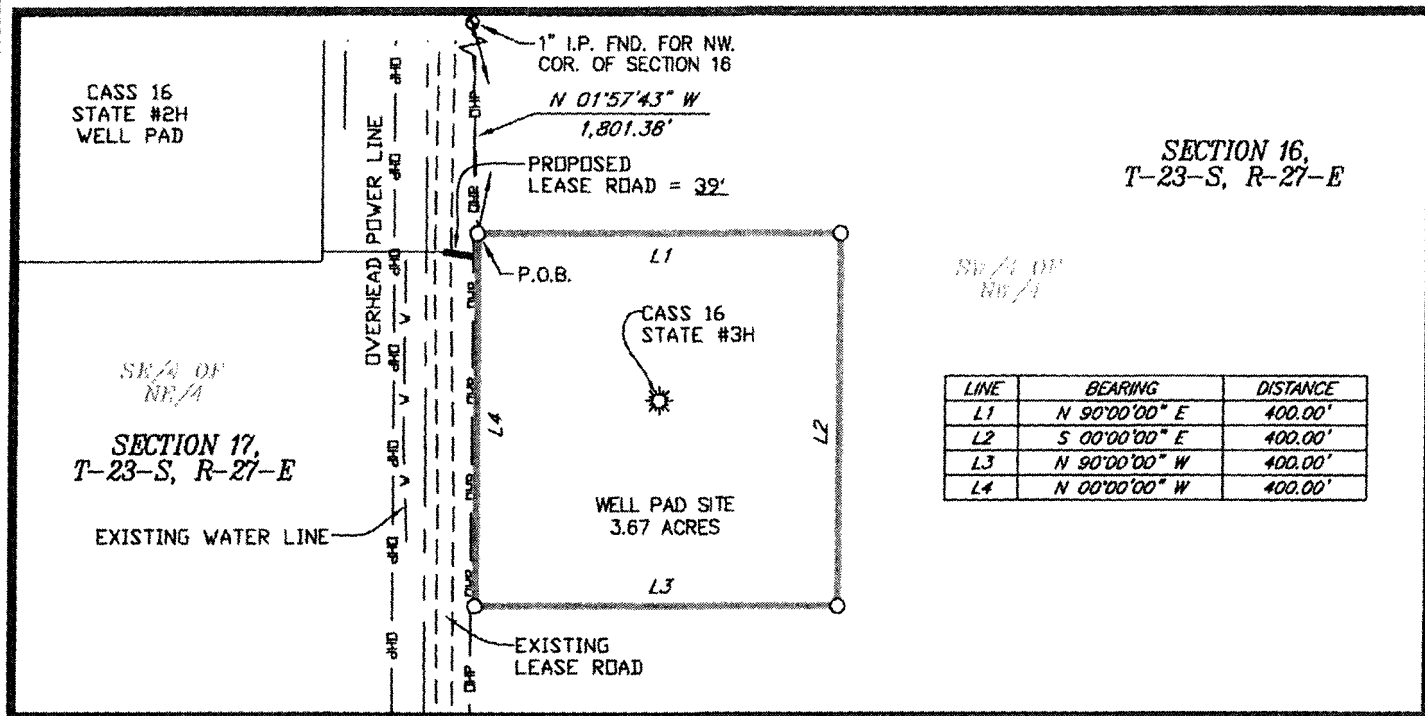

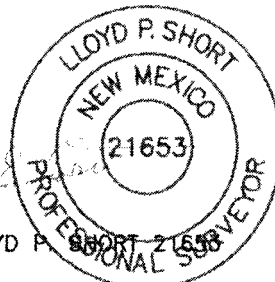

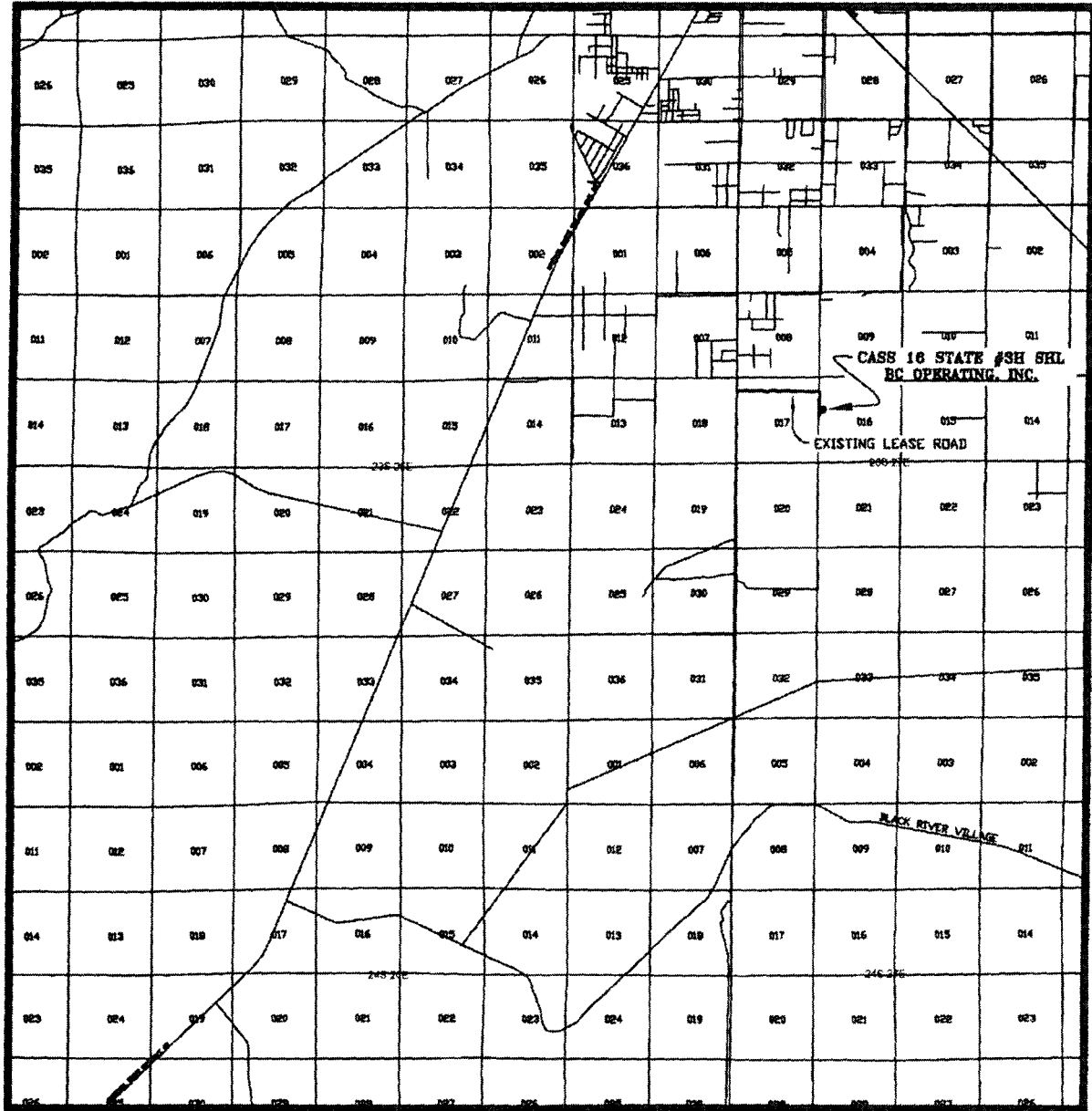
