 8/2/17 - Tagged CIBP at 6340'. Circulated 150 bbls plugging mud to surface. Pressure tested casing from 6340' to surface, no test. Spotted 90 sx Class "C" cement from 6340'-5452' calc TOC. WOC. Tagged TOC 6125'. Loaded casing and pressure tested 6125' to surface to 500 psi, held good. Spotted 75 sx Class "C" cement from 6125'-5327' calc TOC.
 8/3/17 - Tagged TOC at 5438'. Spotted 25 sx Class "C" cement from 4869'-4622' calc TOC. Spotted 25 sx Class "C" cement from 2679'-2433' calc TOC. Perforated at 1454'. Attempted injection rate, unable. Spotted 75 sx Class "C" cement from 1509'-768' calc TOC. WOC.
 8/4/17 - Tagged TOC 818'. Perforated at 483'. Attempted injection rate, unable. ND BOP. Spotted 50 sx Class "C" cement from 523' up to surface. Topped off well.
