**Describe Cause of Problem and Remedial Action Taken.**  
Oil storage tank had a hole on the bottom of the tank resulting in the release. Upon discovery the production was switched into a different tank. The tank was then emptied.

**Describe Area Affected and Cleanup Action Taken.**  
10 BBLS of Oil was released from the storage tank. The release originated at the bottom of the storage tank where a hole developed. All released fluids remained inside the lined SPCC containment. A vacuum truck was dispatched and 10 BBLS of Oil were recovered. Once fluids were removed the liner was visually inspected by Devon field staff for any pinholes or punctures and none were found. Based on this inspection there is no evidence that the spill fluids left the lined containment.
