Drill 12 7/8" hole (9/8/17) to 4380' & set 9-5/8" 36# J-55 BTC csg @ 4365', pump 20 BBLs dyed fresh water + 20 BBLs gel spacer then cmt w/ 1195 sxs (398 BBLs) PPC w/ additives, 12.9 PPG, 1.87 yield and follow w/ 155 sxs (37 BBLs) PPC w/ additives, 14.8 PPG, 1.33 yield, circ. 402 sxs (134 BBLs) to surface (9/9/17). Install wellhead pack off and test to 5000 psi for 15 min, good test.
