Re-sqz'd 35 sx class C cmt @ 1835' & displaced to 1700'. WOC. 07/20/17 Tagged plug @ 1690'. Perf'd csg @ 840'. Sqz'd 60 sx class C cmt @ 840' & displaced to 720'. WOC. Tagged plug @ 700'. Perf'd csg @ 60'. ND BOP, NU well head. Sqz'd 40 sx class C cmt @ 60' & circulated to surface. Riggged down and moved off. 07/21/17 Moved in backhoe and welder. Dug out cellar. Cut off well head. Welded on "Underground Dry Hole Marker". Backfilled cellar. Cut off deadmen. Cleaned location, moved off. BLM's Robert Gornd was on location and witnessed.


