10/5/17 - Set a 4-1/2 inch CIBP at 2307 ft. Tagged CIBP. Loaded and circulated casing to surface with plugging mud. Pressure tested casing to 500 psi, held good. Spotted 100 sx Class C cement from 2307 ft - 860 ft calc TOC. WOC to tag. Tagged TOC 1003 ft. Tag witnessed by BLM representative.

10/7/17 - Spotted 70 sx Class C cement at 1003 ft and circulated up to surface. Topped off well with cement.

10/10/17 - Cut off wellhead. Installed dry hole marker and cut off anchors. WELL IS PLUGGED AND ABANDONED.
