RIH & set 9-5/8" 47# L80 BTC csg @ 4355', pump 20 BBLs gel spacer w/ red dye then cmt w/ 1810 sxs (604 BBLs) PPC w/ additives, 12.9 PPG, 1.87 yield followed by 160 sxs (38 BBLs) PPC w/ additives, 14.8 PPG, 1.33 yield, circ. 316 BBLs (947 sxs) to surface. Pressure test csg to 2250 psi for 30 min., good test.
