3/28/06 Set 13-3/8" 48# H-40 ST&C 8rd casing at 430'. Cemented with 320 sx "C" Neat (yld 1.32, wt 14.8). Tailed in with 200 sx "C" with 2% CaCl2 (yld 1.32, wt 14.8). Cement circulated to surface. Tested casing to 600 psi for 30 min. WOC 27 hrs 15 min. Reduced hole to 12-1/4" and resumed drilling.

4/2/06 Set 9-5/8" 36# J-55 ST&C 8rd casing at 1500'. Cemented with 500 sx 35/65 Poz "C" with 6% D20 + 5% D44 + 3% S1 + .2% D46 + 5#/sx D24 + .25#/sx D29 (yld 12.6, wt 12.6). Tailed in with 200 sx "C" with 2% S1 (yld 1.32, wt 14.8). Cement circulated to surface. Tested casing to 1500 psi for 30 min. WOC 18 hrs. Reduced hole to 8-3/4" and resumed drilling.
