The Poker Lake Unit 367H was spud 12/21/2012, hole was lost and the well abandoned.

This well pad adjoins the well pad for Poker Lake Unit #428H. The 367H pad was downsized to 200' x 350' and the tank battery for the 428H was built. A portion of the Northeast side was reclaimed. Excess caliche was used to build berms on location.

A diagram of the tank battery is attached.
