Pressured up on perfs. Spotted 30 sx class C cmt @ 1032-852'. WOC.

12/20/17 Tagged plug @ 852'. Perf'd csg @ 440'. Set packer @ 31', pump'd into perfs, did not have circulation on 8 1/4. 8 1/4 was on vacuum. Sqz'd 80 sx class C cmt @ 440-80'. Perf'd csg @ 60'. Pressured up on perfs. Spotted 20 sx class C cmt @ 80' & circulated to surface. Rigged down and moved off.

12/21/17 Moved in backhoe and welder. Dug out cellar. Cut off well head. Welded on "Below Ground Dry Hole Marker". Backfilled cellar. Cut off deadmen. Cleaned location, moved off.
