RIH & set 5-1/2" 20# P-110 DQX csg and set @ 14865', pump 100 BBLs mud push then cmt w/ 300sks (77 BBLs) PPC w/ additives, 13.2 PPG, 1.38 yield, followed by 1201 sks (309 BBLs) PPC w/ additives 13.2 PPG, 1.38 yield. Estimated TOC= 6500'. For second stage, performed Bradenhead squeeze cementing w/ 192 sks (43 BBLs) PPC w/ additives, 14.8 PPG, 1.33 yield, followed by 778 sks (232 BBLs) PPC w/ additives 12.8 PPG, 1.76 yield, followed by 288 sks (86 BBLs) PPC w/ additives, 12.8 PPG, 1.76 yield. Ran echometer, TOC = 430'. Notified BLM of cement job, ND BOP, install night cap, install packing and pressure test to 5000 psi, good test. Release rig (12/20/17).
