Mack Energy proposes to lay (2) 10" lay flat surface lines from our Round Tank Pit to our White Rock Federal 2H location. Total Distance of these lines will be 14,168.3' in length. Lines will carry 105,000 bbls of produced water from our frac pit to location for the purpose of fracing the White Rock Federal 2H. Anticipated frac dates are 4/15-5/15/2018. We ask for a 30 day window to allow for schedule conflicts. These lines will be laid on the surface along side of the existing road, within 2' of the roads edge.
