On 2/5/18, MIRUSU. TOH w/rods, pump, & tbg.. (Existing perfs are 57 holes @ 3247'-3528'). W/5-1/2" RBP @ 2540' & 5-1/2" PKR @ 2509', PT RBP to 3500 psi-OK & PT 5-1/2" csg to 1500 psi-OK. TOH.

Set a 5-1/2" CBP @ 3230'. Perf 1st stage Yeso @ 2962'-3181' w/27 holes. Set 5-1/2" pkr on 3.5" 9.3# L-80 frac string @ 2878'. On 2/26/18, treated perfs w/1500 gal 15% HCL & fraced w/30,240# 100 mesh & 190,335# 30/50 sand in slick water. TOH w/3-1/2" tbg & PKR.

Set 5-1/2" CBP @ 2920'. Perf 2nd stage Yeso @ 2538'-2881' w/25 holes. Treated perfs down 5-1/2" csg w/ w/1500 gal 15% HCL & fraced w/31,120# 100 mesh & 315,045# 30/50 white sand in slick water.

CO after frac, drilled CBPs @ 2920' & 3230' & CO to PBTB @ 3591'. On 3/2/18, landed 2-7/8" 6.5# L-80 tbg @ ~2750'. Released completion rig on 3/5/18. Completed well as a single Yeso oil well.
