Failure to comply with the INC may result in assessment as outlined in 43 CFR 3163 and may also incur penalties 43 CFR 3165. All self-certified corrections must be postmarked no later than the next business day after the prescribed time frame for correction.

Section 109(d) of the Federal Oil and Gas Royalty Management Act of 1982, as implemented by the applicable provisions of the operating regulations at 43 CFR 3163.3(f), provides that any person who knowingly or "fully" prepares, maintains, or submits false, inaccurate, or misleading reports, notices, affidavits, records, data, or other written information required by this part shall be liable for a civil penalty of up to \$25,000 per violation for each day such violation continues, not to exceed a maximum of 30 days.

Review and Appeal Rights

A person contesting a decision shall request a State Director review of the Written Order. This request must be filed within 20 working days of receipt of the Notice with the appropriate State Director (see 43 CFR 3165.3). The State Director review decision may be appealed to the Interior Board of Land Appeals, 20 North Quincy Street, Suite 300, Arlington, VA 22203 (see 43 CFR 3165.4).
