

Said centerline of easement being more particularly described as follows:

Commencing from a 2" iron pipe w/BC found for the southeast corner of Section 9, T23S-R31E, N.M.P.M., Eddy County, New Mexico;

Thence N 66°28'31" W, a distance of 454.68' to the **Point of Beginning** of this easement, having coordinates of Northing=477774.66 feet, Easting=713647.96 feet, and continuing the following courses;

Thence N 31°05'51" E, a distance of 241.14' to the **Point of Ending**, having coordinates of Northing=477981.15 feet, Easting=713772.50 feet, from said point a 1" iron pipe w/ BC found for the east quarter corner of Section 9, T23S-R31E, N.M.P.M., Eddy County, New Mexico bears N 07°01'54" E a distance of 2269.68', covering a total of **241.14' or 14.61 rods** and having an area of **0.166 acres**.




