7/9/18 – MIRU and blew down well. Pumped 80 bbls to kill well.
7/10/18 – Opened well and bled off pressure. POOH with production equipment. Pumped 30 bbls to kill well. NU BOP. Set a 4-1/2" CIBP at 1230'. Tagged CIBP. Pressure tested to 500 psi, good.
7/11/18 – Spotted 85 sx Class "C" cement from 1230' up to surface. Topped off well with cement.
7/19/18 - Cut off wellhead. Installed dry hole marker and cut off anchors. **WELL IS PLUGGED AND ABANDONED.**

NOTE: A Subsequent P&A Form C-103 was inadvertently sent on November 7, 2011 on this well.
