6/15/03 Squeezed 4 squeeze holes at 8250' with 200 sx "H" with additives. Tailed in with 125 sx "H" Neat cement. Perfs squeezed off with 163 sx in formation. Circulated 125 sx cement up annulus to pit. Circulated out 125 sx cement, left 5 sx on top of retainer, left 7 sx in casing, 163 sx in formation.

6/19/03 Perforate Canyon 8152'-8174' (45), 8188'-8206' (37).

6/21-22/03 Acidize Canyon with 2500g gelled 20% IC HCL acid with 23 ball sealers. Acidize Canyon with 30,000g 20% HCL acid.
