Mixed @ 14.8 #/g w/ 1.33 yd. Displaced w/77 bbls of BW. Plug down @ 9:00 A.M. 04/24/18. Circ 223 sks of cmt to the pits. Test BOPE to 5000# & Annular to 3500#. At 11:00 A.M. 04/25/18, tested csg to 1500# for 30 minutes, held OK. Drilled out with 12 1/4" bit. FIT test to EMW of 10.5 PPG.
