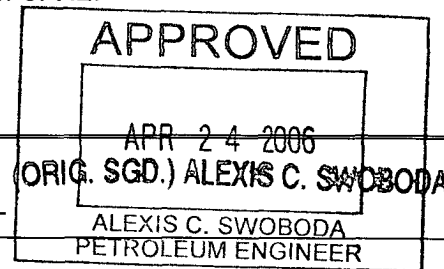

Re-frax at 3480'-3489' with approximately 10-15 bbls per minute of asicd and 70% quality foam with binary frax using approximately 100,000# brady sand frac with 130 tons of Co2 and 3230cscf of N2.
