**Set CIBP @ 12435'. Dump 10' Class H cmt on top of CIBP. Perf the Morrow "A" @ 12377' - 12394' (54 shots). Swab test. Acidz w/ 750 gal Clay Safe H acid. Swab/flow test. Frac down csg w/ 20K# 18/40 versaprop.**

**Set CIBP + 35' cmt @ 12350'. Perf the Strawn Lime @ 11453' - 11509' (9 shots). Acidz w/ 2000 gal NE Fe 15% HCl acid. Swab/flow test.**

**Set CIBP + 35' cmt @ 11400'. Perf the Wolfcamp Lime @ 10438' - 10518' (13 shots). Acidz w/ 2500 gal NE Fe 15% HCl acid. Swab/flow test.**
