THE WELL IS CURRENTLY DOWN DUE TO A PIN HOLE LEAK IN THE NIPPLE UNDER THE PUMPING TEE, AND THE LEAK HAS BEEN TEMPORARILY REPAIRED. SHUT IN STATUS OF 6 MONTHS THROUGH APRIL 30,2019 IS REQUESTED, PENDING THE COMPLETION OF AN ENGINEERING AND GEOLOGICAL REVIEW TO ASSESS FEASABILITY AND OPTIONS OF CONTINUED BENEFICIAL USE FOR THIS WELL.
