POH w/ 93 jts of 2 7/8" tbg & 120 ¾" rods. 10/29/18 Set 5 ½" CIBP @ 1900'. Circulated hole w/ MLF. Pressure tested casing, held 500 psi. Spotted 35 sx class C cement w/ 2% CACL @ 1900-1600'. WOC. Tagged plug @ 1606'. Spotted 35 sx class C cement @ 1000-700'. WOC. 10/30/18 Tagged plug @ 706'. Perf'd casing @ 562'. Pressured up on perfs to 500 psi. ND BOP.
