Set 5 1/2" CIBP @ 2235'. Gas flow stopped. Circulated hole w/ salt gel. Pressure tested csg, held 500 psi. Spotted 40 sx class C cmt @ 2235-1830'. WOC. 11/27/18 Tagged plug @ 1817'.
