"C" + 2% CaCl2 (yld 1.34, wt. 14.8). PD at 10:05 AM, 5/15/2003. Bumped plug to 800 psi, held okay. Circ. 124 sxs. WOC 28 hrs. Drilled out at 2:00 PM, 5/16/2003. Reduced hole to 12 1/4" and resumed drilling.

PD at 5:15AM, 5/20/2003 Bumped plug to 1080 psi, held okay. Circulated 120 sxs. WOC 23 hrs., 45 min. Reduced hole to 8 3/4" and resumed drilling.
