Circ 150 sks of cmt to the pits. Test BOPE to 5000# & Annular to 3500#. At 8:00 P.M. 10/09/18, tested csg to 1500#, held OK. FIT test to 10.5 PPG EMW. Drilled out with 12 1/4" bit.


