XTO Permian Operating, LLC, requests a variance to batch drill the Ross Draw 25-36 Fed Com 103, 123H, 72H & WX 22H wells. In doing so, XTO will set surface and intermediate casing on all wells, followed by the production casing. XTO will ensure that each well is cemented properly and the well is dead; with floats holding, no pressure on the intermediate csg annulus, and the installation of a TA cap as per GE recommendations. XTO will contact the BLM to skid the rig to drill the surface and intermediate, followed by the production casing on the remaining wells on the pad.
