RIH & set 7-5/8" 26.4# HCL-80 FJ & SF csg 9537', pump 40bbl spacer then cmt w/ 165sxs (43bbl) class C w/ additives 13.2ppg 1.65 yield followed by 400sxs (133bbl) class C w/ additives 12.9ppg 1.92 yield. Full returns throughout job, circ 30sxs cmt to surface.
