11/2/18 - RIH w/282 jts 2-7/8" tubing and set @ 8,956', packer @ 8,942'. Test tubing to 1500 psi for 15 min while testing csg to 1000 psi for 15 min, all tests good.

11/9/18 - Rig released, shut in well.
