1/16/18: RIH with 3-3/8" slick guns to perf 3spf, 120degree phasing at the following depths: 2534', 2559', 2579', 2602', 2625', 2682' and 2691' (21 holes). Run packer and acidize with 4000gal 15% NEFE HCL, dropping 7/8" 1.3sp gravity ball sealers evenly spread with clusters of 10 til all balls and acid were gone. Flushed with 35 bbls fresh water displacing to bottom perf at 2691'.

1/17/18: RIH with rods, pump, and tubing. Put well back on production.
