IN THE MEANTIME, WE ARE PRODUCING THE AMOCO FED 11 WELL 1 (API# 30-015-22975) AND/OR AMOCO FEDERAL 11 #9 WELL (API# 30-015-33916) ON A MONTHLY BASIS TO TEMPORARY PRODUCTION FACILITIES. AN ADDITIONAL FORM 3160-5 NOTICE TO RETURN WELL TO PRODUCTION WILL BE SUBMITTED TO BLM ONCE THE FACILITY REPLACEMENT IS COMPLETED AND WELL HAS STARTED BACK UP.
