Spud 17 1/2" hole @ 385'. Ran 370' of 13 3/8" 54.5# J55 ST&C Csg. Cemented with 400 sks Class C w/0.5% CCl2. Mixed @ 14.8#/g w/1.22 yd. Displaced w/51 bbls FW. Plug down @ 7:30 AM 07/10/19. Circ 109 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 6:30 A.M. 07/11/19, tested csg to 1500# for 30 mins, held OK. FIT to 10.5 PPG EMW. Drilled out with 12 1/4" bit.

07/12/19

TD'ed 12 1/4" hole @ 2545'. Ran 2530' of 9 5/8" 40# HCL80 LT&C Csg. Cemented with 600 sks Class C (35:65:6) w/additives. Mixed @ 12.5#/g w/ 1.85 yd. Tail w/200 sks Class C Neat w/additives.
