Treated perfs w/1500 gal 15% HCL & fraced w/33,000# 100 mesh & 249,460# 40/70 coolset sand in slick water. Set 5-1/2" CBP @ ~3841'. Perfed 3rd stg @ 3512'-3811' w/30-0.42" holes. Treated perfs w/1500 gal 15% HCL & fraced w/32,858# 100 mesh & 285,008# 40/70 coolset sand in slick water. Set 5-1/2" CBP @ 3420'. Perfed 4th stg @ 3128'-3395' w/28-0.42" holes. Treated perfs w/1500 gal 15% HCL & fraced w/30,140# 100 mesh & 216,940# 40/70 coolset sand in slick water. On 8/26/19 MIRUSU. CO after frac, drilled CBPs @ 3420', 3841', & 4277', & CO to PBTD @ 5145'. On 8/30/19, landed ESP on 2-7/8" 6.5# L-80 IPC production tbg @ 3462'. ESP intake @ 3091'. Released
