6/8/2019 - 6/19/2019: Drill 12 1/4" hole. TD @ 20425'.

6/20/2019 - 6/22/2019: Run 5 1/2" csg (20.0# P-110 BTC) @ 20415' w/3340 sx of class C cmt & 100sx class H. Est. TOC 5900'.

6/23/2019: Rig released.
