10/21/19 - MIRU and POOH with production equipment.
10/22/19 - NU BOP. Set a 4-1/2" CIBP at 7952'.
10/23/19 - Spotted 3 sx Class "H" cement on top of CIBP. WOC. Circulated 125 bbls water with 32 sx salt water gel as plugging mud. Pressure tested to 500 psi, held good. Tagged TOC at 7913'. Perforated at 7883'. Attempted circulation into perforations. Pressured up to 500 psi with no leak off. Spotted a 30 sx Class "H" cement plug from 7903'-7548' calc TOC.
10/24/19 - Tagged TOC at 7555'. Perforated at 5431', established injection rate. Pumped a 40 sx Class "C" cement plug from 5431'-5277' calc TOC. Full circulation up 8-5/8" casing during job. Tagged TOC at 5239'. Perforated at 4256', established injection rate. Pumped a 40 sx Class "C" cement plug from 4256'-4114' calc TOC. Full circulation up 8-5/8" casing.
10/25/19 - Tagged TOC at 4078'. Perforated at 2270', established injection rate. Pumped a 40 sx Class "C" cement plug from 2270'-2148' calc TOC. Full circulation up 8-5/8" throughout job. WOC. Tagged TOC at 2089'. Perforated at 1319'. Pumped a 40 sx Class "C" cement plug from 1319'-1169' calc TOC. Full circulation up 8-5/8" casing throughout job. WOC.
10/28/19 - Tagged TOC at 916'. Perforated at 876', established injection rate. Pumped a 30 sx Class "C" cement plug from 876'-792' tagged. Full circulation up 8-5/8" casing throughout job. WOC. Pumped a 45 sx Class "C" cement from 145' up to surface down 4-1/2" casing and up 8-5/8" casing to surface. Topped off with cement.
10/31/19 - Cut off wellhead and installed dry hole marker. Cut off anchors and cleaned location. WELL IS PLUGGED AND ABANDONED.
