Went in and fixed parted tubing and bad casing to prepare to plug and abandon this well. Spliced and pulled casing at 2222'. Established injection rate of 1.5BPM at 1800# below retainer at 8045'. Squeeze with 60 sx "H" with additives. Dumped 129' cement on top of retainer. Perforate 4 squeeze holes at 5900'. Set retainer on wireline at 5850'. Set 475 sx "C" cement plug and dumped 129' cement on top of retainer. TOC at 4000' behind 4-1/2" casing. RIH and tagged at 4166'. Tubing plugged. RIH and circulate brine mud from 4166'-2200'. Spotted 60 sx "C" cement from 4166'-3990'. POH with 35 stands 2-3/8" tubing. ND BOP and wellhead. PU 4-1/2" casing with spear and LD 54 joints 4-1/2" casing. LD 6 joints 3-3/4" washpipe, 6 4-1/8" DC's, 6 3-1/8" DC's and 64 joints 2-7/8" tubing. NU wellhead and BOP. RIH with 71 joints 2-3/8" to 2261'. Spot 60 sx "C" with additives across 4-1/2" casing stub at 2224'. POH with 35 stands. RIH and tag at 2164'. Spot 50 sx "C" with additives at 1158'-1050'. Wait 2 hrs. RIH and tag at 1016'. Spot 60 sx "C" neat at 460'-360'. ND BOP and wellhead. Spot 25 sx "C" neat from surface to 60'. Clean location. Release all rental equipment. Cut off wellhead and install dry hole marker.
