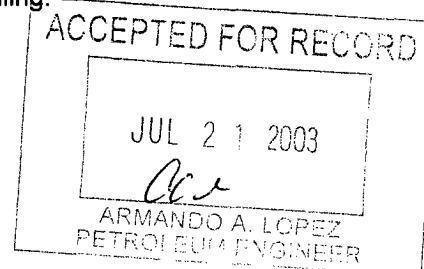

6/25/03 Set 11-3/4" 42# casing at 620'. Cemented with 300 sx 35:65 Poz "C" with additives. Tailed in with 200 sx "C" with additives. Cement circulated to surface. WOC 20 hrs 30 mins. Reduced hole to 11" and resumed drilling.

6/28/03 Drilled 11" hole down to 1950'. Reduced hole to 7-7/8" and resumed drilling.
