I. Background

On January, 30, 2002, Yates submitted to the OCD District 2 office a C-141 report reflecting a release of 8 barrels of oil form a malfunctioning back pressure valve. A vacuum truck was called and 6 barrels of oil was recovered from the area. The report reflected that one area of approximately 20 feet by 60 feet was affected as well as another adjacent area measuring approximately 15 feet by 20 feet by the fine spray of oil coming from the back pressure valve. This area remains unremeditated as reflected in the **Letter of Violation** dated February 13, 2006.

II. Surface and Ground Water

The nearest groundwater of record is listed on the ChevronTexaco, Eddy County Depth To Groundwater Water Well Facilities Trend Map dated 2/9/2005 shows depth to groundwater approximately 250 feet making the site ranking for this site a zero (0).

III. Soils

The surface soils in the area are predominantly sandy.

IV. Scope of Work

Yates Petroleum Corporation proposes to have contractors remove a production heater treater, separator, and associated piping from area contacted by release to allow equipment to work safely in the area of the release. Once the production equipment is removed, sand from the adjacent area will be blended with the affected sands to bring area into an OCD RRAL field soil vapor headspace of 100ppm.

Contaminated material from around the area of the wellhead will be removed and taken to an OCD approved land farm. A field soil vapor headspace measurement will be taken before soils are replaced at the wellhead to insure the RRAL of 100ppm is met.
