The contents of the old pit will be mixed 3 to 1 with CKD, with fresh water added, and placed in the burial pit. The burial pit will be covered with a 20mil plastic cap, and

Covered with 3' of top soil, and re-seeded to restore vegetation. The old pit will be filled with dirt removed from the burial pit, and capped with 3' of top soil. The OCD

Will be notified 24hrs before any testing event, and pit rule 50 will be followed for all operations.
