Additional Comments: Registration for 2nd encapsulation trench south side of the former tank battery area. An encapsulation trench will be excavated and lined with a 12 mil. Synthetic liner on former tank battery site. Excavated Historic Hydrocarbons will then be emplaced into the encapsulation trench. A 20 mil. Synthetic liner will then be placed over the pit contents with a min. of a 3' over lap of the underlying trench area. The encapsulation trench will then be backfilled back to grade using a min. of 3' of clean soil and like material. A one call & 48 hour notice will be provide to the Oil Conservation Division before pit closure actions began.

Pit closure start date will by NA end date NA. Mud seed in the will be placed on pit area.
