Devon Energy Production Company, LP is applying with the NM OCD for approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas. This pool was pre-approved by NM OCD Division order PC-1108.

The San Andres is perforated at 1869-2328' and the Yeso is perforated from 2855-3196'. Average production from the SA is 0.86 oil and 7.35 gas. Average production from the Yeso is 3.14 oil and 2.65 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 78.5% and gas is 26.5%. For the San Andres formation, oil is 21.5% and gas is 73.5%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.
