1. POOH W/ PKR & TBG.
2. SHOOT 4 SQZ HOLES @ 835' (50' BELOW BASE SALT @ 785').
3. SET CIBP ON TBG @ 2350'. SPOT 10 SX CLASS "C" NEAT CMT ON TOP OF CIBP. PULL UP TO 2100' & CIRC WELL BORE FULL OF 9 PPG BRING MIXED W/ 25 SX PER 100 BBLs OF SALT GEL (APPX 35 BBLs CSG VOLUME).
4. PULL TBG TO 685'. PUMP 45 SX CLASS "C" + 2% CACL2 TO THE END OF TBG (PLACING CMT INSIDE & OUTSIDE CSG). TOOH W/ TBG, LOAD CSG. WOC A COUPLE OF HRS & TAG CMT.
5. SHOOT 4 SQZ HOLES @ 562' (50' BELOW 8 5/8" SHOE @ 512'). PUMP 200 SX CLASS "C" + 2% CACL2 DOWN 4 1/2" CSG & UP 8 5/8" X 4 1/2" ANNULUS TO FILL THE WELL F/ 562' TO SURFACE W/ CMT.
6. CUT W/H & CSG OFF 3' BELOW GROUND LEVEL & REMOVE. WELD PLATE ONTO 8 5/8" STUB. WELD 4" DRY HOLE MARKER ONTO PLATE SUCH THAT 4' OF IT IS ABOVE GROUND LEVEL.
7. CUT OFF ANCHORS & RECLAIM LOCATION PER BLM SPECS.
