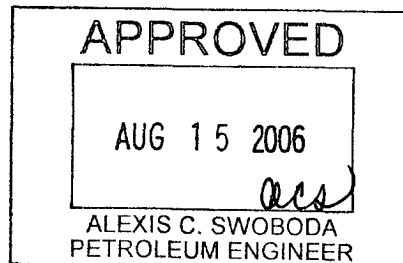

BEPCO, L.P. respectfully request to alter the toal depth and casing program that was approved on the application for permit to drill or re-enter dated April 13, 2006. The total depth of the well will be lessened to 13,500' MD from 15,000' MD in order to pursue potential within the Wolfcamp series. As a result, the 4-1/2", 15#, P-110 liner will be shortened to 800' from the original 2,850'.

This change is due to more recent geological data gathered from recent drilling activity.
