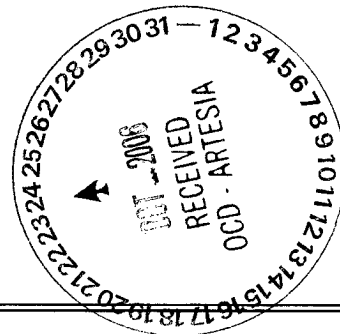

At 6:30 am 09/28/06, tested 5 1/2" casing to 2895# for 30 minutes, held OK. Set 112k on slips.

09/29/06...Released rig.

10/02/06...Ran CBL and found TOC at 2300'.
