3. Cut 4 1/2" @ 2350'. Displace Casing with Mud or Brine Gel between Cement Plugs. ③ AT 95 FT + TAG
4. Install Dry Hole Marker, Clean Location. ④ Surface Plug min. 50 ft.
5. Level Pits, Rat Hole and Cellar. Set 4" Steel Marker, Clear Location cleared of all Debris and Equipment.
6. Notify BLM and NMOCD of Plugging Operations.


