- 11/6/06 Set a 5-1/2" CIBP at 5014' with 35' cement on top. Spotted a 25 sx Class "C" cement plug with 3% CaCl from 3332'-3232'. WOC 4 hrs. Tagged cement plug at 3228'. Pumped 50 sx Class "C" cement with 3% CaCl and displace to a depth of 1884'.
- 11/7/06 TIH with sinker bar on wireline to a depth of 2100'. Did not tag any cement. Pumped 70 sx Class "C" cement with 3% CaCl to a depth of 1700'. WOC 4 hrs. Tagged cement at 1870'. Perforated 4 squeeze holes at 560'. Established circulation. Pumped 200 sx Class "C" cement. Good cement to pit out of braden head.
- 11/15/06 Installed dry hole marker. **WELL IS PLUGGED AND ABANDONED. FINAL REPORT.**
