Perforate Cisco 6314'-6320' (14), 6340'-6344' (10), 6358'-6364' (14), 6380'-6396' (34), 6416'-6426' (22), 6432'-6438' (14), 6530'-6538' (18) and 6556'-6562' (14) and possibly Canyon 7444'-7676'. Stimulate as needed.
