Comments on Inspection: Location in need of attention, misc junk lying throughout location. Tank #1 in battery has leaked at the bottom in the past. Tank is rusted out in several places. Fence around site is down in several places. Photos taken. Area at base of rusted tank will require remediation. Please submit a remediation work plan proposal to the District 2 office no later than 4/7/07. Plan is to be formulated based on site ranking, contaminant delineation and OCD Rules and Guidelines. Violation Rule 19.15.3.116 [NMAC] and Rule 19.15.1.13 [NMAC]

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well. Such a hearing may result in imposition of CIVIL PENALTIES for your violation of OCD rules.
