2/26/07 Pull out 2 3/8" production and packer. RIH w/ 8 5/8" CIBP and set at 2265'.
TIH and tag CIBP @ 2265'. Pump mud.

2/28/07 Pumped 15 sx Class C cement from 2265' to 2207'. Spot 7.8 bbls mud.
Test CIBP and cement plug to 1000 psi. Test good.
Pumped 45 sx Class C cement from 485' to 311'. Spot 2.5 bbls mud. WOC 4 hrs.
Go in hole and tag plug at 289'. Pumped 35 sx Class C cement from 62' to surface.
Circulate 13 sx to cellar.
Kent Caffall - BLM Carlsbad on site to witness tag and all 3 plugs being set. Satisfied that all requirements were met.
Rig down and prepare to cut off wellhead and weld on P&A marker.
